**Greeting Committee Report:** No Welcome baskets were delivered during July.

- **Bike Path Repair**: Bike paths were resealed.
- **Handicap Ramp Repairs**: No estimates received as yet. Needs to confirm if bumps need to be on ramps.
- **Mowing and Spraying**: Gecko Landscaping has mowed Common areas twice and will be contacted to mow bike paths again this year.

## **New Business:**

Need to contact owners of vacant lots to have them mowed.

Dan Johnson reported that we need to appoint at least one new board member so that we can have a quorum at meetings; in event there are items to be voted on.

## **Open Discussion:**
